

2024 SPRING LARGE ITEM PICK UP PROGRAM

Claystone Waste is once again pleased to help your residents with their spring cleaning as part of our Large Item Pick Up Program. This bi-annual Program is provided at no charge to regional municipal residents.

In the past, regular garbage was being put out for collection through this Program, instead of just large items such as sofas and washing machines. This year, we will be using the central bin collection system in all the towns and villages except Viking.

Residents will have several days in which to take their spring cleaning items to a centralized bin for collection. Please note that if your residents are unable to get their large items to the bin, please contact our Collections staff at 780.663.2038, extension 133 to schedule a pickup. Please note that this will be only for **large items** and the items must be taken to the curb per the scheduled time.

Please note that both regional rural and urban residents can take their large items to any of our transfer stations year-round. We ask that they check our website to see what large items are acceptable at which transfer station site.

The dates for the upcoming large item collection for each of the municipalities will be:

Monday, April 29 to Thursday, May 2 - Hamlet of Bruce

No curbside collection.

Bring your items to the large bins located at:

- Community Hall (2 bins)
- Lift Station (1 bin)

Monday, May 6 to Thursday, May 9 – Village of Ryley

No curbside collection.

Bring your items to the large bins located at:

- Old carwash beside Village Office 50 St & 50 Ave
- Truck stop area close to cardboard bin 51 St & 50 Ave
- Trailer park close to the 4 yd bins 53 ST & 52 Ave
- Grassy area north end of Village on 57 Ave between 49 & 50 St

Friday, May 10 to Thursday May 16 – Town of Tofield

No curbside collection.

Bring your items to the large bins located at:

• West side of the Truck Parking – 51 St & southside of 51 Ave (5 bins)





Monday, May 20 to Thursday, May 23 – Village of Holden

No curbside collection.

Bring your items to the large bins located at:

- Empty lot at 5024 50 St
- Gazebo Park entrance located on 51 St
- On east side of 48 St
- West side of Public Works shop 4920 48 Ave

If your residents cannot get their large items to one of the collection bins, please have them reach out to our Collections Department for assistance. They will arrange to pick the large item up directly from the resident's front yard. Please note that Claystone employees will not enter a private residence to collect large items.

Thursday, May 30–Town of Viking

Curbside pick up, **large items** must be <u>on the street</u>—not on your lawn or driveway, as per their new waste bylaw #2024-697. See below for acceptable items. If the items have not been picked up three days after the scheduled date above, please direct them to call our office at 780.663.2038 extension 133 and speak with someone in the Collections Department.

Fridges, freezers, water coolers and window air conditioning units are acceptable, however there is a \$25 charge for Freon removal. Urban residents will need to pay for the Freon removal at the local Town/Village office. Once payment has been made, a sticker will be provided that needs to be placed on either the front or side of the appliance.

Ryley, Lindbrook and Viking Transfer Stations accept Freon-containing appliances year-round for the same \$25 charge. Payment can be made by credit card or debit at the Transfer Station when bringing the appliances for disposal. We do not accept cash at our sites.

Items acceptable for collection in this Program (both curbside and central bins) include mattresses, sofas, recliners, white goods (stove, washing machine, etc.) and appliances, tires and propane tanks.

Items that are unacceptable for the curbside collection program in Viking include grass clippings, trees, tree branches, bags of household garbage, small items that would fit into the neighbourhood waste bin, and cardboard boxes. These items can be broken down and placed in the bin in the alley. These items CAN be placed in the central collection bins.

Electronic waste should be taken to a transfer station. Chunks of concrete or cement must be taken directly to the landfill site near Ryley.





We ask for your support with this free Program. Please share this information with your residents. If at all possible, it would be helpful if your public works staff could let us know if the central bins are full before the scheduled pick up day.
