## **POSITION DETAILS:**

- Position Type: Full-time Temporary (position duration approximately 6-8 months)
- Hours of Work: Available to work non-regular hours if required, as per section six (6) "Hours of Work" of the Collective Agreement with I.U.O.E. local 955.
- Salary Range: \$28.08 - \$34.17 per hour.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

- Operate and perform routine maintenance on a wide variety of construction equipment including pad foot packers and smooth drum.
- Conduct regular inspections, troubleshooting, and repairs as needed to ensure the safe and efficient operation of equipment.
- Perform a variety of manual labor duties, including but not limited to loading and unloading materials, site preparation, and general labor tasks.
- Clean the equipment as scheduled and/or required.
- Reports to the Manager of Transportation, performing duties as an equipment operator II, with additional tasks as required.

## **EDUCATION & EXPERIENCE REQUIREMENTS:**

- High School Diploma or equivalency preferred.
- Experience operating medium equipment is preferred but not required; training will be provided to qualified candidates.

- A driver's abstract will be required for successful applicants.
- Class 3 with Air Brake Endorsement would be an asset.
